MOTION FOR EXPEDITED TREATMENT

COMES NOW KCP&L Greater Missouri Operations Company (“GMO” or the “Company”), in accordance with Missouri Public Service Commission (“Commission”) Rule 4 CSR 240-2.080(14), and, for its Motion for Expedited Treatment, states to the Commission as follows:

1. With this Motion, GMO is filing a proposed Missouri Energy Efficiency Investment Act (“MEEIA”) Program Income-Eligible Weatherization tariff sheet. The tariff revision consists of the addition of: (1) reallocation of funds from United Services to West Central Missouri Community Action; and (2) explanatory language below the allocation table describing the reallocation of funds. This tariff sheet contains an issue date of September 29, 2014 and an effective date of October 29, 2014.

2. The subject tariff sheet carries an effective date of October 29, 2014. However, GMO seeks the Commission’s expedited treatment of this tariff sheet. To that end, GMO asks that the tariff sheet becomes effective October 9, 2014.

3. The grant of this Motion may have a positive benefit for GMO’s customers in that the changes to the existing Income-Eligible Weatherization program will be implemented in a timely manner. Staff supports GMO’s request for expedited treatment. This Motion has been filed as of the earliest date the Company knew of its necessity and could prepare the required

documents. There will be no negative effect on GMO's customers or the general public if the Commission acts by October 9, 2014.

WHEREFORE, for all the foregoing reasons, KCP&L respectfully requests the Commission consider this Motion for Expedited Treatment and to approve the proposed tariff sheets effective October 9, 2014.
