**NON-UNANIMOUS MOTION FOR EXTENSION**

COMES NOW KCP&L Greater Missouri Operations Company (“GMO”) and Staff (“Staff”) for the Missouri Public Service Commission (“Commission”), and for their *Non-Unanimous Motion for Extension*:

1. On September 6, 2019, GMO and Staff filed their *Non-Unanimous Motion to Suspend Procedural Schedule*.

2. On September 9, 2019, the Commission issued its Order granting said motion and suspending the procedural schedule until September 16, 2019 in order to accommodate the parties’ settlement discussions.

4. On September 16, 2019, GMO filed a request for a one-day extension of time (until September 17, 2019) to finalize and file a settlement agreement.

5. On September 17, 2019, GMO filed a request for a one-day extension of time (until September 18, 2019) to finalize and file a settlement agreement.

3. Staff, OPC, Nucor, and GMO are still in the process of finalizing a settlement agreement and request that the Commission grant an additional extension of one day (to September 19, 2019) for the filing of a settlement agreement.

WHEREFORE, GMO, Nucor, OPC, and Staff respectfully request the Commission consider this request and issue an order granting a one-day extension.
