ORDER ESTABLISHING ENDING ACA BALANCES

Issue Date: February 28, 2018 Effective Date: February 28, 2018

The Commission opened this case to receive the 2015-2016 Purchased Gas Adjustment (PGA) and Actual Cost Adjustment (ACA) filings of Summit Natural Gas of Missouri, Inc. On December 11, 2017, the Staff of the Commission filed a recommendation and memorandum indicating Staff has completed an audit of the billed revenues and actual gas costs for the 2015-2016 period included in Summit's computation of its ACA balances.

Staff's recommendation and memorandum sets out the ending balances contained in Summit's ACA filing, and did not recommend any adjustments to the ending balances of the company's former SMNG service area (Rogersville and Branson Divisions) or its Northern service area (Gallatin Division). Staff did recommend a \$50 adjustment to Summit's Sothern service area (Warsaw and Lake of the Ozarks Divisions. Staff also offered some non-monetary recommendations regarding Summit's policies and practices with regard to billed revenue and actual gas cost, reliability analysis and gas supply planning, and hedging. Summit responded to Staff's non-monetary recommendations on January 25, 2018. On January 26, Staff replied to

Summit's response, indicating there are no issues that require Commission resolution and advising the Commission to establish the ending ACA balances indicated in Staff's December 11 recommendation.

After reviewing Staff's recommendations and Summit's response, the Commission concludes that Staff's ending ACA balances should be accepted as a resolution of Summit's 2015-2016 ACA audit. Because Staff's recommended balances are unopposed, the Commission will give this order a ten-day effective date.

THE COMMISSION ORDERS THAT:

1. The ending (over)/under recovery balances for Summit Natural Gas of Missouri, Inc.'s 2015-2016 Actual Cost Adjustment account balances as of August 31, 2016, are established as provided in the following tables:
