**ORDER GRANTING EXTENSION AND ACKNOWLEDGING  
WITHDRAWAL OF TRACKING NO. YG-2022-0151**

Issue Date: November 30, 2021

Effective Date: November 30, 2021

On November 10, 2021, Spire Missouri Inc. filed a compliance tariff with a December 10, 2021 effective date. The compliance tariff was assigned Tracking No. YG-2022-0151. The Commission directed an expedited review by the Staff of the Commission (Staff), with Staff's recommendation or a request for an extension due by November 19, 2021. The Commission also directed any objections to the compliance tariffs be submitted by November 19, 2021. On November 17, 2021, Spire Missouri filed substitute tariff sheets for Tracking No. YG-2022-0151.

On November 19, 2021, the Office of the Public Counsel (OPC), Vicinity Energy Kansas City, Inc. (Vicinity) and Midwest Energy Consumers Group (MECG) each filed objections to the compliance tariffs. Also on November 19, 2021, Staff filed a request for an extension of time to submit its recommendation regarding the substituted compliance tariffs. Staff indicated that its requested extension would allow Spire Missouri additional time to correct and refile its compliance tariffs, as well as allow further review by Staff. The Commission granted Staff an extension until November 29, 2021.

On November 23, 2021, Spire Missouri filed a second set of substitute tariff sheets. These refiled tariffs have issue dates of November 23, 2021, and effective dates of

December 23, 2021, and were assigned Tracking No. YG-2022-0162. Spire Missouri noted in its transmittal letter that these tariff sheets were refiled to reflect the Commission's decisions in its *Amended Report and Order*. The second substitute compliance tariffs, Tracking No. YG-2022-0162, replaced, in its entirety, Tracking No. YG-2022-0151. Therefore, the Commission acknowledges that Spire has withdrawn Tracking No. YG-2022-0151 and it will not become effective. The Commission now has Tracking No. YG-2022-0162 before it.

On November 29, 2021, Staff requested an additional extension of time to file its recommendation regarding Tracking No. YG-2022-0162. Staff indicates it is in the process of reviewing that compliance tariff filing and requests the Commission grant it until December 10, 2021, to file its recommendation. The Commission finds the request reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Spire's withdrawal of Tracking No. YG-2022-0151 is acknowledged.
2. No later than December 10, 2021, Staff shall file a recommendation regarding Tracking No. YG-2022-0162.
3. Any party wishing to file objections or a recommendation regarding Spire Missouri's compliance tariffs shall do so no later than December 10, 2021.
4. Any party wishing to file a response to Staff's recommendation shall do so before 2:00 p.m. on December 14, 2021.
5. This order shall be effective when issued.
