ORDER SETTING ON-THE-RECORD PRESENTATION

On December 11, 2020, Spire Missouri Inc. d/b/a Spire filed tariff sheets designed to implement a general rate increase for natural gas service, and to consolidate, to the extent possible, the rate structures of its two service areas known as Spire East and Spire West. On various dates, the eleven parties submitted a total of four partial stipulations and agreements, as follows:

- Filed July 23, 2021, a *Non-Unanimous Stipulation and Agreement* (the July 23 Stipulation)
- Filed July 30, 2021, a Partial Stipulation and Agreement (the July 30 Stipulation)
- Filed August 5, 2021, a *Nonunanimous Stipulation and Agreement* (the August 5 Stipulation)
- Filed August 12, 2021, a *Partial Stipulation and Agreement* (the August 12 Stipulation)

Relative to all four partial stipulations, more than seven days have passed and no party has objected to any of the agreements. The Commission will schedule an on-the-record presentation for the parties to have the opportunity to present the agreements and to answer any Commission questions concerning the agreements.

THE COMMISSION ORDERS THAT:

1. An on-the-record presentation for the parties to present the four partial stipulations and agreements and to respond to Commission questions is scheduled for August 25, 2021, at 1:30 p.m. to be held by video and teleconference via WebEx. The presentation will also be live-streamed via the Commission's website at psc.mo.gov. Interested persons who will not be actively participating in the presentation should access it via the live stream. The link and access code to participate in the presentation via WebEx will be emailed to counsel for the parties.
