SECOND ORDER GRANTING STAFF'S MOTION FOR AN EXTENSION OF TIME TO FILE A RECOMMENDATION AND AFFIRMING THAT CURRENT ACA RATES ARE INTERIM SUBJECT TO REFUND

On April 21, 2022, the Staff of the Commission (Staff) filed a motion requesting a second extension of time to file its recommendation. Staff states that it has almost completed its review in this case. Staff requests a few more weeks to complete its investigation and finish drafting its recommendation. Staff also requests that any order granting the extension state that the current Actual Cost Adjustment (ACA) rates remain interim subject to refund.

Staff requests to have until May 27, 2022, to file its recommendation, but notes it will file its recommendation sooner if feasible. The Commission finds that the extension of time requested is not excessive and is necessary for Staff to complete its recommendation, which will be beneficial to all the parties and the Commission. The Commission will grant the motion for an extension.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension is granted. Staff shall file its recommendation in this matter no later than May 27, 2022.
2. The current ACA rates remain interim subject to refund, pending the Commission's final decision in this matter.

3. This order is effective when issued.
