## ORDER TO FILE RECOMMENDATION REGARDING LOCAL PUBLIC HEARINGS

On October 20, 2021, the Commission issued its Order Setting Procedural Schedule and Adopting Test Year. The order stated that local public hearings should occur in February 2022, subject to Commission Order. The Commission will direct the parties to file a pleading recommending the number, locations,<sup>1</sup> dates and times for the local public hearings.

### THE COMMISSION ORDERS THAT:

1. No later than November 19, 2021, the parties shall file a pleading recommending the number, locations, dates and times for local public hearings.
2. This order shall be effective when issued.
