**ORDER CANCELLING DECEMBER 7, 2021 DISCOVERY CONFERENCE**

On October 20, 2021,<sup>1</sup> the Commission issued its Order Setting Procedural Schedule and Adopting Test Year ("Procedural Schedule"). The procedural schedule set discovery conferences for November 9, December 7, March 8, 2022, and April 5, 2022. On November 8, the Commission issued an order requiring any party who wanted a discovery conference hearing on December 7 to file an advance notice or other pleading so advising the Commission and parties. No party filed a notice or other pleading. The Commission will cancel the December 7 discovery conference. The Commission will also issue an order requiring any party who wants a discovery conference hearing on March 8 or April 5 to file an advance notice or other pleading so advising the Commission and parties.

**THE COMMISSION ORDERS THAT:**

1. The Discovery Conference scheduled for December 7, 2021, is cancelled.
2. Any party wishing a discovery conference on March 8 or April 5, 2022, shall file an advance notice or other pleading no later than the Friday immediately prior to the scheduled conference so advising the Commission and parties.
