STAFF NOTICE REGARDING TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and files its *Staff Notice Regarding Tariff Sheet* and states as follows:

1. On January 13, 2023, The Empire District Gas Company d/b/a Liberty (“EDG”) filed a tariff sheet in Tariff Tracking No. JG-2023-0126 that EDG stated in its accompanying cover letter was being filed to remove extraneous language from the tariff sheet. The tariff sheet has an issue date of January 13, 2023, and an effective date of February 12, 2023.

2. Staff reviewed the tariff sheet filed in Tariff Tracking No. JG-2023-0126 and contacted EDG with suggestions regarding revisions to further conform the tariff sheet to the Commission-approved *Stipulation and Agreement*. Following, on January 26, 2023, EDG filed a substitute that Staff has reviewed and recommends the Commission allow to go into effect for service:

WHEREFORE, Staff submits its *Staff Notice Regarding Tariff Sheet* and recommends the Commission allow the substitute tariff sheet filed in Tariff Tracking No. JG-2023-0126 to go into effect by operation of law.


