ORDER SUSPENDING PROCEDURAL SCHEDULE AND POSTPONING EVIDENTIARY HEARING

On July 12, 2022, the parties in this matter, Summit Natural Gas of Missouri, Inc., the Staff of the Commission, and the Office of the Public Counsel filed a *Motion to Suspend the Procedural Schedule*. In the motion, the parties stated that they have reached an agreement in principle that would resolve the only issue identified by the parties to be decided in the evidentiary hearing scheduled for July 13-14, 2022. The parties requested that the Commission suspend the currently ordered procedural schedule in this matter to allow the parties to prepare and file a stipulation and agreement reflecting their agreement in principle.

The Commission will grant the motion and postpone the evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. The currently ordered procedural schedule is suspended and the evidentiary hearing scheduled for July 13-14, 2022, is postponed.
2. The parties shall either file a stipulation and agreement by July 22, 2022, or file a status report.
3. This order shall be effective when issued.
