- 2 JUDGE PRIDGIN: Good morning, we are on the
- 3 record. This is the prehearing conference in Case No.
- 4 GR-2008-0136 in the matter of Missouri Gas Utility,
- 5 Inc.'s, purchased gas adjustment factors to be audited
- 6 in its 2006/2007 actual cost adjustment.
- 7 I am Ronald Pridgin, I'm the Regulatory Law Judge
- 8 assigned to preside over this prehearing conference
- 9 being held October 8, 2008, Room 305, in the
- 10 Governor's Office Building. The time is approximately
- 11 10:05 a.m.
- 12 I would like to get entries of appearance from
- 13 counsel beginning with the Staff of the Commission.
- 14 MS. SHEMWELL: Lera Shemwell representing
- 15 the Staff of the Missouri Public Service Commission,
- 16 Post Office Box 360, Jefferson City, Missouri 65102.
- 17 JUDGE PRIDGIN: Thank you. On behalf of

- 10 indeed go to hearing, I will be involved in a
- 11 telecommunications arbitration case largely the rest
- 12 of the year, and it's going to monopolize my time.
- So if you did pick a hearing date, say, in 2008,
- 14 it's not that I couldn't -- I could probably oblige
- 15 people as far as the hearing date itself, but as far
- 16 as the report and orders, you might be waiting a
- 17 while. That's just because I have one of those silly
- 18 deadlines from Congress that says I have to get this
- 19 arbitration order in. So that's something you might
- 20 want to take into account.
- 21 It's possible, but unlikely, another judge would
- 22 get assigned this case because of my work schedule.
- 23 Because of rate cases going on, I think that's pretty
- 24 unlikely. So just for your information, in case you
- 25 are looking for hearing dates, that's something you

- I believe I understand the dispute that's
- 5 remaining, and it sounds like we have people on the
- 6 line and people here in the hearing room from Staff
- 7 who are prepared to discuss the issue.
- 8 Is there anything else counsel needs from me
