PROCEEDINGS 1 2 JUDGE HATCHER: Let's go on the record. First, I would like to ask that everyone please mute themselves unless 3 they are speaking. That will cut down on not only the noise 4 5 level, but it will prevent audio feedback. 6 Today is June 23rd, 2021. The Missouri Public 7 Service Commission has set this time for a local public hearing 8 in Case Number GR-2021-0108, which is captioned as In the Matter 9 of Spire Missouri Inc. d/b/a Spire's Request for Authority to 10 Implement a General Rate Increase for Natural Service Provided 11 in the Company's Missouri Service Areas. The Commission has 12 scheduled this local public hearing to give members of the 13 public a chance to comment about Spire's application. 14 The Missouri Public Service Commission regulates 15 the rates charged by public utility companies in Missouri to 16 ensure that those rates are just and reasonable. The Commission 17 also regulates the quality of service and safety of the 18 operations of those public utilities. The Commission is made up 19 of five commissioners. The commissioners are appointed by the 20 Governor and confirmed by the Senate. The commissioners employ 21 a staff of engineers, accountants, attorneys, financial 22 analysts, and other specialists in the field of utility 23 regulation. My name is Charles Hatcher. I am the regulatory 24 25 law judge and will preside over this hearing. With me today I

1	have Chairman Ryan Silvey and I also have Commissioner Glen
2	Kolkmeyer.
3	This is an official hearing of the Missouri
4	Public Service Commission and the statements and testimony of
5	witnesses will be recorded by a court reporter and must be given
6	under oath.
7	I will begin by asking counsel to enter their
8	appearances for the record. Spire, please go ahead.
9	MR. APLINGTON: Good evening, Judge Hatcher.
10	This is Matt Aplington representing Spire Missouri Inc, the
11	petitioner. 700 Market Street, St. Louis, Missouri 63101.
12	JUDGE HATCHER: Thank you, sir.
13	And for the commission staff. Remember if you
14	are on the phone, we need to press *6 to unmute. We will go
15	ahead and move forward. Office of the Public Counsel.
16	MR. CLIZER: Good evening, Your Honor. John
17	Clizer on behalf of the Missouri Office of the Public Counsel,
18	business address Governor Office Building Suite 650, 200 Madison
19	Street, PO Box 230, Jefferson City, Missouri 65102. Thank you.
20	JUDGE HATCHER: Thank you, sir.
21	And we do have a number of intervening parties.
22	Instead of calling that list, if there are any representatives,
23	by that I mean attorneys, for any of the intervening parties
24	that would like to enter their appearance for the record.
25	MR. MILLS: Thank you, Judge Hatcher. This is

1	Lewis Mills. I am the attorney for Vicinity Energy Kansas City.
2	I am with the firm of Bryan Cave Leighton Paisner in Jefferson
3	City.
4	JUDGE HATCHER: Thank you, Mr. Mills.
5	The process tonight will be to call the names
6	listed on the sign-up sheet in the order that they appear. When
7	I do call your name, please go ahead and unmute. I will then
8	place you under oath and ask you to state and spell your last
9	name, and then ask that you offer your comments to the
10	Commission.
11	I do want to make two quick announcements.
12	First is, the Commission has not made any decisions in this case
13	and they cannot answer any questions today because they have to
14	remain impartial until after all of the evidence is presented.
15	Secondly, I just want to repeat the announcement
16	about unmuting. We will go a little bit slower to make sure and
17	allow everyone time to unmute themselves. If you're on a
18	browser or on the WebEx app, it's just pressing a button within
19	that. If you are on the phone, you press *6 to unmute.
20	As for the witnesses, as I said, I will call the
21	list of people that have signed up and then after that, I will
22	call for anyone who wishes to testify that did not already sign
23	up. I will do that right after I finish the list of that those
24	that have. Our first witness is Frank Ruege or Ruege. The last
25	name is R-U-E-G-E. If you are on the phone, you need to press

1	*6 to unmute. Frank Ruege. Okay. We will call them again at				
2	the end. Troy McKinney. Is there a Troy McKinney here to				
3	testify? All right. Ruth Withey. The last name is spelled				
4	W-I-T-H-E-Y. Ruth Withey. Again, if you are on a telephone,				
5	you need to press *6 to unmute yourself. Okay. The next name I				
6	have is Janie Morreale. The last name is spelled				
7	M-O-R-R-E-A-L-E, Janie Morreale? Nan Neusel(ph)? Is there a				
8	Nan Neusel? Margie Stanbursky(ph)? And Allison Kite? Okay.				
9	I'm going to keep that list handy. We will go through the list				
10	again.				
11	Right now I'm going to open it up to any person				
12	who would like to testify that did not preregister. If they				
13	would like to speak up, that would bring you to the front of my				
14	screen and then I will swear you in you can provide your				
15	comments to the commissioners.				
16	MS. CONLEY: Conley, C-O-N-L-E-Y.				
17	JUDGE HATCHER: Yes, if you could give me your				
18	name please.				
19	MS. CONLEY: Conley, Desiree Conley.				
20	C-O-N-L-E-Y.				
21	JUDGE HATCHER: Thank you, Ms. Conley, let me				
22	swear you in.				
23	(Witness sworn.)				
24	JUDGE HATCHER: Thank you, Ms. Conley. Please				
25	go ahead and provide your comments to the commissioners.				

1	THE WITNESS: My comment is, we don't need
2	another rate increase on the gas with the coronavirus, rate
3	increases and everything, light bill, water bill. We don't need
4	another increase just for a company to get more money so they
5	could make more money, when they want more money, go to the
6	customers to get more money. And that is my comment.
7	JUDGE HATCHER: All right. Thank you very much.
8	I appreciate you being here and testifying.
9	Do any of the commissioners have any questions
10	for Ms. Conley?
11	COMMISSIONER SILVEY: No questions, Judge.
12	Thank you for your testimony.
13	JUDGE HATCHER: Thank you, Mr. Chairman.
14	Ms. Conley, thank you. You are excused from our
15	virtual witness stand. You do not need to hang up. You are
16	welcome to stay on the line for the rest of the hearing.
17	Is there anyone else who would like to provide
18	testimony to the Commission? Again, if you are on the phone you
19	press *6 to unmute.
20	THE WITNESS: My name is Lori Thompson.
21	JUDGE HATCHER: Ms. Thompson, let me go ahead
22	and swear you in.
23	(Witness sworn.)
24	JUDGE HATCHER: Thank you, Ms. Thompson. Go
25	ahead and please give us your comments.

1	THE WITNESS: Well, with the coronavirus and the			
2	way the jobs that have went totally out, Missouri has been			
3	pretty strong about staying open with their jobs. Some people			
4	have lost their jobs. And the people that don't have jobs that			
5	are on disability or SSI have a fixed income. So how are they			
6	going to be able to cope with not having our Spire the way it			
7	has been normally then and raising the bill on the people like			
8	that. May I ask that?			
9	JUDGE HATCHER: I am really sorry. We had a our			
10	question and answer period before we started the testimony.			
11	That was to give everyone a chance to talk more informally. We			
12	can't have any of the commissioners answer any questions tonight			
13	because we still have evidence that is coming into the case so			
14	they need to remain impartial.			
15	THE WITNESS: Okay. I apologize.			
16	JUDGE HATCHER: No. You are completely fine. I			
17	appreciate you being here and offering your testimony. I'll			
18	take that as a rhetorical question, but you are free to contact			
19	any of the parties to try and get maybe a better explanation of			
20	that. I will make sure to give out some contact information at			
21	the end here.			
22	THE WITNESS: I appreciate that.			
23	JUDGE HATCHER: Thank you, Ms. Thompson.			
24	Do we have any commissioner questions for			
25	Ms. Thompson?

2	Thank you for your testimony.				
3	JUDGE HATCHER: Thank you, Mr. Chairman.				
4	MS. YARBOROUGH: Judge, this is				
5	JUDGE HATCHER: Yes?				
6	MS. YARBOROUGH: this is Sherry Yarborough.				
7	JUDGE HATCHER: Yes, Ms. Yarborough. Hold on				
8	just a minute and I will swear you in.				
9	(Witness sworn.)				
10	JUDGE HATCHER: Thank you, ma'am. If you could				
11	please provide your comments.				
12	THE WITNESS: Okay. I was on a				
13	question-and-answer session earlier and actually it went my				
14	phone went dead completely, so I actually had to dial back in				
15	and re-enter the program in order to be a part of this. So I				
16	was just wondering if I'm thinking that those individuals did				
17	not know to dial back in, all of the individuals you called				
18	earlier.				
19	Also, I would like to piggyback on what the two				
20	testimonies stated earlier, that it is really a bad time to do a				
21	rate increase. It is pretty difficult on us. I don't know if				
22	you all realize how difficult it is. It is just one more is				
23	one more weight on our shoulders and it's really weighing us				
24	down. So I would like them to hold off on the rate increase				
25	until the economy gets better. So that is my comment.				

1	JUDGE HATCHER: Thank you, Ms. Yarborough. I				
2	appreciate you being here to testify.				
3	Do we have any commissioner questions for				
4	Ms. Yarborough?				
5	COMMISSIONER SILVEY: No questions, Judge.				
6	Thank you for your testimony.				
7	JUDGE HATCHER: Thank you, Mr. Chairman.				
8	MS. HAHN: Hi.				
9	JUDGE HATCHER: Yes, who is this?				
10	MS. HAHN: My name is Amara.				
11	JUDGE HATCHER: I'm sorry, your last name?				
12	MS. HAHN: Hahn.				
13	JUDGE HATCHER: Hahn. All right. Let me swear				
14	you in.				
15	(Witness sworn.)				
16	JUDGE HATCHER: Thank you. Please go ahead.				
17	THE WITNESS: Hi, my name is Amara. I have been				
18	a Kansas City resident my whole life. I am 26. I have been				
19	paying bills for a relatively short amount of time,				
20	comparatively. And all the time that I have been paying bills				
21	my wages have not increased. I know that lots of residents have				
22	commented on the fact that it is not a good time, but there is				
23	never a good time because our wages haven't increased and while				
24	I think it is appropriate to say the majority of the				
25	commissioners probably have their finances figured out where				

1	they wouldn't be affected by a \$42 annual increase. However,				
2	for myself I barely get to spend any money on myself as a human				
3	as I've been and it is unethical and immoral to ask me and				
4	the majority of Kansas City residents that are at or near the				
5	poverty line to say, give us more money. You and every other				
6	utility company do not see the effects because your finances are				
7	set. And while I am so happy for you, I am sad for myself and				
8	I'm sad that I do have to advocate and just say no, rather than				
9	I have to stay with this commissioner and this hearing to				
10	advocate for myself when I already do not have enough time.				
11	Thank you.				
12	JUDGE HATCHER: Ms. Hahn, thank you for taking				
13	the time out of your schedule to be here and testify.				
14	Do we have any Commissioner questions for				
15	Ms. Conn (ph)?				
16	COMMISSIONER SILVEY: No questions. Thank you				
17	for your testimony.				
18	Thank you, Judge.				
19	JUDGE HATCHER: Thank you, Mr. Chairman.				
20	MS. WELLS: Carolyn Wells.				
21	UNIDENTIFIED SPEAKER: Hi.				
22	JUDGE HATCHER: Yes, I will take Ms. Wells first				
23	and I see that we have one more after that. Ms. Wells, I will				
24	swear you in now.				
25	(Witness sworn.)				

JUDGE HATCHER: Thank you, ma'am. Please go ahead.

THE WITNESS: My comment is does anyone else 3 4 live through winter except me? I think this was the was most 5 brutal winter that I've lived in Missouri and have had in at 6 least a five-year span. And that's why it was terrible because 7 I don't know how I would've paid my gas bill this winter because 8 we had a grid shut down because everybody have to use gas to 9 stay warm. And so we had a 45-minute grid shut down just so we could stay warm. Okay. And so now here we are after all this 10 11 that we've been through just to keep warm and to pay our bills 12 this winter, past winter. Maybe I am one of the fortunate ones 13 that I was smart enough to be on a payment plan, but I don't 14 know how if I was not on a payment plan I would have come up 15 every month with 160 or \$70 because the winter was brutal. 16 Every month my average bill was 100 and -- (audio cut out).

Although I appreciate the opportunity of having that -- let me be on a payment plan, I really did -- I really was appreciative this winter for that plan. But still, I think I'm at the point where I cannot afford to pay another dime in gas bill. I'm trying to pay off what I used this winter, just to stay warm. I'm not in agreement right now with a gas increase at all. Thank you very much.

24JUDGE HATCHER: Thank you, Ms. Wells for your25testimony.

Are there any commissioner questions for 1 Ms. Wells? 2 3 COMMISSIONER SILVEY: No questions, Judge. 4 Thank you. 5 JUDGE HATCHER: Thank you, Mr. Chairman. 6 And we had --7 MR. BOYD: Dennis Boyd. 8 JUDGE HATCHER: Dennis Boyd, thank you, sir. 9 Let me swear you in. 10 (Witness sworn.) 11 JUDGE HATCHER: Thank you, sir. Please go 12 ahead. 13 THE WITNESS: Yes, I would appeal to the Commission to deny a rate increase at this time. I think there 14 15 should be careful consideration and Spire should be required to 16 develop a comprehensive plan to demonstrate that they are 17 considering all income levels of all of their customers, 18 especially residential customers since that is the demographic 19 that is most impacted by these rate increases. 20 Secondly, in that development plan they should 21 include representatives from the residential customer base to 22 demonstrate that they are operating in good faith and not going 23 out and conducting focus groups and asking customers what they 24 want in order to demonstrate that they've actually gone out into 25 the community. I ask and also appeal that they consider

demonstrating that they focused on their customer base that are on a fixed income. That is a reoccurring theme in this call. I also ask that they deny -- based on the timing, coming out of a pandemic, loss, job loss it's a lot of stress on people and the timing is just fatally flawed.

6 The other reason why I ask that they deny it at 7 this time is because when they led off, they lead with talking about their shareholders and that doesn't demonstrate that 8 9 they've taken careful consideration and done market research on 10 the customer base and what the customer experience is, has been 11 financially, psychologically, and emotionally at this point in 12 time given the context of where we are as a society and as people who live here in the state of Missouri. For those 13 14 reasons, I'm appealing to the Commission to deny the rate 15 increase at this time until they have demonstrated that they 16 have actually worked hand in hand in taking careful consideration into the rate increase that as it is going to 17 18 impact adversely the residential customer base. 19 Thank you. 20 JUDGE HATCHER: Thank you, Mr. Boyd. Ι 21 appreciate you being here and your testimony. 22 Any questions from the commissioners? 23 COMMISSIONER SILVEY: No questions, Judge. Thank you. 24 25 JUDGE HATCHER: Thank you. And are there any

other witnesses that would like to testify? 1 2 MS. DELACRUZ: Yes, Jacqueline Delacruz. 3 JUDGE HATCHER: Ms. Delacruz, let me swear you 4 in. 5 (Witness sworn.) 6 JUDGE HATCHER: And Ms. Delacruz, go ahead. 7 THE WITNESS: I just wanted to say that I do not 8 agree with the rate increase at this time. I don't feel like 9 the infrastructure expenses that were made were anything that 10 affected me or that people approved. It was kind of something 11 that I feel like they decided on their own. So for that reason, 12 I just don't feel like a rate increase would be appropriate at 13 this time. Thank you. 14 JUDGE HATCHER: Thank you, ma'am. I appreciate 15 your testimony. 16 Were there any questions for Ms. Delacruz? 17 CHAIRMAN SILVEY: No questions from me. Thank 18 you, Judge. 19 JUDGE HATCHER: Thank you. Do we have any other 20 persons that would like to testify to the Commission? 21 MS. CARTER: Hi. 22 JUDGE HATCHER: Go ahead. Do we have anyone 23 else that wishes to testify? If you're on the phone, you press 24 \*6 to unmute. Okay. I am not hearing anyone come forward. 25 MS. CARTER: I'm sorry.

1 JUDGE HATCHER: I've got two people. Could the 2 young lady go first. 3 MS. CARTER: Sure. My name is Kristin Lacey 4 Carter and --5 JUDGE HATCHER: Let me swear you in, Ms. Carter. 6 MS. CARTER: I'm so sorry. Thank you. 7 (Witness sworn.) 8 JUDGE HATCHER: Thank you. Please go ahead. 9 THE WITNESS: I am both a residential and a commercial customer as a small business. I think that I 10 11 strongly feel the Commission should not approve a rate increase 12 at this time, not just for me in my personal situation but also for those of us who are on fixed incomes in Missouri with wages 13 also being suppressed. We've got younger generations who also 14 15 don't have great upward mobility. I would like to give them a 16 chance to be more successful coming out of the pandemic instead 17 of taking on big debt. 18 So I would like to not see a rate increase at 19 this time for the financial health of Missourians at large, but 20 I am also concerned by reporting that I have seen in The 21 Missouri Independent -- and I was just pulling up that article 22 that I had. On June 7th, just a few days ago, they reported 23 that Spire can use some of the rates that we pay to lobby and 24 that is also a hugely inappropriate thing to do to raise rates 25 and lobby against maybe our best interest as small individual

1 customers. 2 So I would like the Commission to ensure that if 3 there does happen to be a rate increase that is being towards 4 things that will be to the payers benefit, not just the 5 shareholders. 6 JUDGE HATCHER: Thank you. I appreciate your 7 testimony. Do you have anything else, ma'am? 8 THE WITNESS: No. That's it. I'm done. 9 JUDGE HATCHER: Thank you, I appreciate that. Ι did not want to rush you off. 10 11 Do any commissioners have any questions for 12 Ms. Carter? 13 COMMISSIONER SILVEY: No questions from me. Thank you, Judge. 14 15 JUDGE HATCHER: Thank you. And there was a 16 gentleman wanting to testify. Ms. Carter, you are excused from 17 our virtual witness stand. I think I have forgotten that for 18 the last couple of witnesses. 19 Was there a gentleman that wanted to testify 20 that just spoke up? 21 MR. ALEXANDER: Yes, Davion Alexander. 22 JUDGE HATCHER: All right. Mr. Alexander, let 23 me swear you in. 24 (Witness sworn.) 25 JUDGE HATCHER: Thank you. Go ahead,

2 THE WITNESS: Okay. I would just like to say that I strongly oppose the increase as well. I'm in agreement 3 with most of the comments that have been made already, that it 4 5 is an extremely bad time. I am not certain that the studies put 6 forth in order to arrive at the numbers that they arrive at have 7 been in good faith. Also, I'd just like to add that there are a 8 number of increases that have either been proposed or have 9 already been acted upon Kansas Citians, as well as throughout 10 the state of Missouri. For instance, nationally you have the 11 qas tax. There are, as far as residential homes are concerned, 12 you have property increases, so -- insurance rates are being 13 proposed for increases or have been increased. So we have all of these increases and Congress approved all this stimulus money 14 15 to help people that have been struggling through this pandemic 16 and it seems like companies like Spire want to come and pretty 17 much take away the impact, the good, positive impact that that 18 stimulus money could very well have in each individual's lives. 19 I completely agree this is a -- bad, bad timing 20 for requesting a rate increase for the company. I also would 21 like -- I'm not sure, I've done the research, but if it is 22 possible for there to be barriers removed for other companies to 23 come in and compete with Spire would be great. It helps to

25 along with this. Again, I haven't done the research. I don't

mitigate these rate increases and the controversy that come

б	behalf of the Kansas Citians or the residents of the state of				
7	Missouri period. Because I would like to be a little bit more				
8	vocal and a little bit more active when these types of cases are				
9	presented to the public are raised. That would be it.				
10	JUDGE HATCHER: Okay. Thank you, Mr. Alexander.				
11	I appreciate you taking the time to come testify today.				
12	Are there any questions for Mr. Alexander?				
13	COMMISSIONER SILVEY: No questions from me.				
14	Thank you, Judge.

16	Mr. Alexander, I will excuse you from our				
17	virtual witness stand. Please feel free to continue to stay on

MS. JOHNSON: That's all right. 1 2 JUDGE HATCHER: Ms. Johnson, let me swear you 3 in. 4 (Witness sworn.) 5 JUDGE HATCHER: Thank you. Please go ahead with 6 your comments. THE WITNESS: I have a concern that in the last 7 8 meeting, the informal meeting that we had prior to this, that 9 they prefaced it with catering to the stakeholders. So there is 10 a gross imbalance. 11 JUDGE HATCHER: Ms. Johnson, you cut out. 12 THE WITNESS: There's a gross imbalance when we 13 put the benefit of the stakeholders above the residents. Those 14 who -- the residents are the ones you are sowing into this 15 industry and into this organization. I just think that is a 16 gross imbalance and it's not good business. That's not good 17 business. It really isn't. That's not ethical. 18 Secondly, hearing all of the testimony prior, 19 especially one of the individuals really broke my heart to hear 20 how some of the people are suffering and to just tap them even 21 harder, that is not good business. That just isn't. The timing 2.2 is just not -- it is just not right. I really think they should 23 consider other options instead of taxing the people because the 24 people sound like they already taxed. So that is me talking as 25 an advocate for the majority of the people. The stakeholders

Thank you. 10 JUDGE HATCHER: Thank you. 11 Ms. Johnson, you are excused from our virtual 12 witness stand. As always, please feel free to stick around for 13 the rest of the hearing. Are there any other persons who would 14 like to testify to the Commission tonight? And recall that it 15 is \*6 on your telephone to unmute. Okay.
