ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: September 29, 2008 Effective Date: October 1, 2008

On July 2,¹ Missouri Gas Energy, a division of Southern Union Company (hereafter "MGE"), filed an application with the Missouri Public Service Commission under Sections 393.1009, 393.1012 and 393.1015, RSMo Cum. Supp. 2007, requesting that the Commission authorize the company to establish an Infrastructure System Replacement Surcharge for numerous gas utility plant projects. On September 18, the Commission approved an ISRS for MGE; however, the Commission rejected the tariff that MGE filed, and allowed MGE to instead file a tariff that comports with the Stipulation and Agreement that MGE and the Staff of the Commission (hereafter "Staff") filed on September 16.

On September 19, MGE filed a tariff with an effective date of October 19. In addition, MGE filed a Motion for Expedited Treatment, asking the Commission to approve the tariff no later than October 1. The Commission's Staff filed its Memorandum on September 23, in which Staff stated that MGE's tariff complies with the Commission's September 18 order. Staff recommends that the Commission approve the proposed tariff to be effective on and after October 1.

Upon review of the pleadings, the Commission finds that MGE's tariff comports with the Commission's September 18 order, and will therefore approve it. Further, the Commission finds that good cause exists for the tariff to become effective in less than thirty days; therefore, the Commission will grant MGE's Motion for Expedited Treatment and approve the tariff to become effective October 1.

THE COMMISSION ORDERS THAT:

- 1. The Motion for Expedited Treatment filed by Missouri Gas Energy, a division of Southern Union Company, is granted.
- 2. The following tariff filed on September 19, 2008, and assigned Tariff No. YG-2009-0210, is approved to become effective on October 1, 2008:
