## ORDER DIRECTING FILING

On June 23, 2022, the Commission issued its Report and Order (Order). That Order authorized The Empire District Gas Company (Empire Gas) to file tariffs that comply with the Order. Those tariffs would allow Empire Gas to collect an additional \$1 million of annual revenue.

On July 7, 2022, Empire Gas filed tariffs that are intended to comply with the Order. The Commission will order Staff to respond, and will allow other parties an opportunity to respond.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation no later than July 18, 2022.
2. Any other responses shall be filed no later than July 20, 2022.
3. This order shall be effective when issued.
