ORDER REGARDING HEARING EXHIBITS

The Commission is issuing this order regarding procedures related to exhibits referenced during the hearing and/or offered into evidence during the hearing to be held July 13-14, 2022.

THE COMMISSION ORDERS THAT:

1. Numbers for exhibits that will be referenced during the hearing and/or offered into evidence during the hearing, including pre-filed testimony, will be assigned numbers as follows:

2. Using their assigned group of exhibit numbers, each party shall prepare a list of exhibits that they intend to offer into evidence and file the list in EFIS no later than 4:00 p.m. on July 11, 2022. If, during the hearing, a party wishes to refer to an exhibit or offer an exhibit into evidence which has not been pre-filed, such an exhibit shall be assigned a number from that party's assigned pool of numbers.

3. Paper copies of all exhibits shall be provided to the court reporter at the time that such exhibits are offered into evidence. In lieu of providing a paper copy to the court

reporter, an exhibit may be e-mailed to the other parties, to exhibits@psc.mo.gov, and to Kenneth.Seyer@psc.mo.gov prior to or at the time the exhibit is utilized during the hearing. Prior to a witness testifying via WebEx, counsel sponsoring the witness shall provide an e-mail address where the witness can receive and review exhibits during the hearing.

4. This order shall be effective when issued.
