On December 12, 2022, the Staff of the Commission (Staff) filed its recommendation regarding The Empire District Gas Company's d/b/a Liberty (Empire) Actual Cost Adjustment filing. Staff expressed some concerns, comments, and recommendations which were set forth in the Billed Revenue and Actual Gas Costs section, the Reliability Analysis and Gas Supply Planning section, as well as the Hedging section of Staff's memorandum. Staff has requested the Commission order Empire to respond within 30 days to Staff's concerns, comments, and recommendations included in the Staff's recommendation and memorandum.

The Commission will direct Empire to respond.
