**ORDER DIRECTING STAFF RECOMMENDATION
AND SETTING TIME FOR INTERVENTION AND RESPONSES**

On September 1, 2021, Union Electric Company d/b/a Ameren Missouri filed proposed tariff revisions (Tracking No. JG-2022-0046) designed to implement its Delivery Charge Adjustment for the 2nd Accumulation Period beginning September 1, 2020 and ending August 31, 2021. The tariff sheets bear a November 1, 2021 effective date. The Commission will direct the Staff of the Commission to file a recommendation, and will establish a deadline for any other entity to file a request for intervention and response to the proposed tariff changes.

THE COMMISSION ORDERS THAT:

1. No later than September 22, 2021, the Staff of the Commission shall file a recommendation regarding Tariff Tracking No. JG-2022-0046.
2. Any other entity wishing to respond to the tariff changes shall file an application to intervene, if not already a party to this matter, and response no later than September 22, 2021.

3. This order is effective when issued.
