ORDER DIRECTING RESPONSES

On December 30, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed an application for approval of changes to Liberty's Infrastructure System Replacement Surcharge (ISRS).

The Staff of the Commission (Staff) filed its recommendation on March 30, 2022. On April 7, 2022, Liberty filed its response. Liberty mostly accepted Staff's recommendations. The exception is Staff's recommendation for the Commission to direct Liberty to have a third-party study conducted regarding Liberty's corporate and overhead allocation methods. Liberty responded stating it had a 2021 third-party review of its Cost Allocation Manual, and that it is currently working with an external accounting and auditing firm to complete a comprehensive capitalization study.

The Commission will direct a response from its Staff regarding Liberty's response.

THE COMMISSION ORDERS THAT:

1. On or before April 15, 2022, Staff shall file a response to the Liberty response filed April 7, 2022.
2. Any other party wanting to respond shall do so on or before April 15, 2022, however, no party except Staff is required to respond.

3. This order shall become effective when issued.
