ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On March 2, 2022, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tariff Tracking Number JG-2022-0230. Liberty projects that the changes to the WNAR tariff sheets will increase the average monthly bill of the typical residential customer in its Northwest, West, and Southeast Districts by \$2.69, \$2.50, and \$1.06, respectively. The tariff sheets bear an April 1, 2022, effective date.

The Staff of Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

THE COMMISSION ORDERS THAT:

1. No later than March 16, 2022, Staff shall file a recommendation regarding Tariff Tracking No. JG-2022-0230.
2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so before noon, 12:00 p.m., on March 21, 2022.
3. This order is effective when issued.
