APPLICATION FOR VIDEO SERVICE AUTHORIZATION

GTC Video, Inc. ("GTC" or "Company"), by and through its undersigned counsel, pursuant to Section 67.2679(7), RSMo 2000 (Cum. Supp. 2007), and in accordance with Missouri Public Service Commission ("Commission") Rule 4 CSR 240-2.060, hereby makes application for a video service authorization that will allow GTC to offer and supply video service and to construct, install, operate, and maintain a video service network in various political subdivisions and unincorporated areas within the state of Missouri. In support of its application, GTC states as follows:

1. GTC is a Missouri corporation with its principal office and place of business at 126 S. Beaver Avenue, P.O. Box 200, Granby, Missouri 64844. GTC provides, or intends to provide, video service to customers in various political subdivisions and unincorporated areas located within the state of Missouri. GTC is not subject to the regulatory jurisdiction of this Commission, except as may be provided under the "2007 Video Services Providers Act," §§ 67.2679 - 67.2714, RSMo 2000 (Cum. Supp. 2007). A copy of GTC's Certificate of Good Standing, issued by the Secretary of State of Missouri, is attached to this application as Appendix A and is incorporated herein by reference.

2. There are no final unsatisfied judgments or decisions pending against GTC from any federal or state agency or court that involve customer service or rates, and GTC has no annual report or assessment fees that are overdue.

4. GTC currently provides or intends to provide "video service" through a "video service network" to customers located in various "political subdivision[s]" within the state of Missouri, as those terms are defined in Section 67.2677, RSMo 2000 (Cum. Supp. 2007). Some of those customers are or will be located within the corporate limits of a city, town, or village while other customers are or will be located in various unincorporated areas within Newton County.

5. In certain political subdivisions, GTC currently provides video service pursuant to a franchise, permit, license, resolution, ordinance, contract, certificate, agreement, or similar arrangement that previously was granted by the governing authority of each such political subdivision. As allowed by Section 67.2679(9), RSMo 2000 (Cum. Supp. 2007), GTC opts to continue to provide

video service in each of the following political subdivisions under the terms and conditions of the existing franchise, permit, license, resolution, ordinance, contract, certificate, agreement, or similar arrangement until each such arrangement expires or otherwise is terminated:

6. GTC also provides or intends to provide video service to customers who are not located in one of the political subdivisions listed in the preceding paragraph. These locations include: (i) cities, towns, and villages that do not require a franchise, permit, license, resolution, ordinance, contract, certificate, agreement, or similar arrangement in order for the Company to offer video service to customers who reside or are located within the corporate boundaries of those cities, towns, and villages; (ii) cities, towns, and villages where GTC is not currently operating; and (iii) unincorporated areas within Newton County. To enable the Company to construct, install, operate, and maintain a video network and to supply video service, GTC asks the Commission to issue, in accordance with Sections 67.2679(4) and (7), RSMo 2000 (Cum. Supp. 2007), a video service authorization that will allow the Company to operate as a video service provider in each of the following political subdivisions and communities:

- 7. As required by Section 67.2679.7, RSMo 2000 (Cum. Supp. 2007), an affidavit, signed by a Company officer, which affirms the following, accompanies this application as Appendix B and is incorporated herein by reference:

 - (b) a list of political subdivisions that are to be served by the Company;
 - (c) the location and principal place of business of GTC and the names of its principal executive officers;
 - (d) that the Company has filed, or will timely file, with the Federal Communications Commission all forms required by that agency prior to offering video service;
 - (e) that GTC agrees to comply with all applicable regulations concerning use of the public rights-of-way, as provided in Sections 67.1830 to 67.1846, RSMo; and
 - (f) that the Company is legally, financially, and technically qualified to provide video service.
- 8. In addition, to fulfill the requirements of Section 67.2679(5), RSMo 2000 (Cum. Supp. 2007), GTC is providing a copy of this application to each of the political subdivisions wherein the Company provides or intends to provide

video service, which will serve to advise and provide notice to each such political subdivision of the Company's intent.

WHEREFORE, GTC requests the Commission to grant this application and to issue, within thirty (30) days of the filing date of this application, a video service authorization that allows the Company to construct a video service network along, across, or on public rights-of-way for the delivery of video service and to provide video service in each of the political subdivisions listed in paragraph 6 of this application.
