# ORDER OPENING A WORKING CASE AND ESTABLISHING A WORKING GROUP REGARDING A RE-WRITE OF SPIRE'S COST ALLOCATION MANUAL AND STANDARDS OF CONDUCT

On June 6, 2018, the Commission's Staff filed a motion asking the Commission to open a working case and establish a working group to assist in the drafting of a revised cost allocation manual and related gas supply and transportation standards of conduct for Spire, Inc. Staff's motion explains the Commission stated in its amended report and order resolving Spire's recent general rate cases that it would be taking that step.<sup>1</sup>

When the working group produces a revised CAM, that CAM must be submitted to the Commission in a new case for the Commission's review and approval.

1. The Commission's Data Center shall provide a copy of this order to all parties in Spire's most recent general rate cases (GR-2017-0215 and GR-2017-0216).<sup>2</sup>
