This file was opened in June 2018, in response to a motion filed by the Commission's Staff asking the Commission to establish a working group to assist in the re-writing of Spire Missouri, Inc.'s Cost Allocation Manual (CAM). The parties have engaged in discussions regarding Spire's CAM during the ensuing years. On May 23, 2022, Spire filed a draft CAM that it asks the Commission to approve.

It is not appropriate to consider approving Spire's CAM in this working case. For that reason, the Commission will transfer Spire's application into a new case. File No. GO-2022-0327 has been opened for that purpose. This working case has now served its purpose and will be closed.

THE COMMISSION ORDERS THAT:

1. Spire Missouri, Inc.'s Draft Cost Allocation Manual and its motion seeking approval of that document is transferred to File No. GO-2022-0327.

2. File No. GW-2018-0367 is closed.
