1. The Commission's Rules of Evidence. The Commission's Rules of

received into evidence by reference.

2. <u>Official Notice</u>. Missouri's Administrative Procedure Act allows the Commission to take official notice in the same manner as courts. "Agencies shall take official notice of all matters of which the courts take judicial notice." §536.070(6) RSMo.

3. <u>Judicial Notice</u>. Missouri courts may take judicial notice "of proceedings in other courts that relate directly to matters at issue." *Great Plains Trust Co. v. Union Pac. R.R. Co.*, 492 F.3d 986, 996 (8th Cir. 2007). Courts may take judicial notice of other proceedings when the cases are interwoven or interdependent. *Environmental Utilities, LLC v. Public Service Comm'n of Missouri*, 291 S.W.3d 256, 265 (Mo. App. WD 2007).
