COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and states:

1. On August 16, 2007, the Commission issued an *Order Adopting Proposed Procedural Schedule* in which it stated the "parties are to agree upon and Staff shall file a list of issues to be heard, the witnesses to appear on each day of the hearing, the order in which they will be called, and the order of cross-examination for each witness. Any issue not contained in the list of issues will be viewed as uncontested and not requiring resolution by the Commission." The Commission set November 16, 2007, as the filing date for the list of issues, order of witnesses and order of cross-examination.

2. The Parties to this proceeding are: SMNG, the Staff, and the Office of the Public Counsel.

3. The Parties have agreed upon following list of issues for this case. The parties believe the list includes all contested issues and properly identifies them.

- a. Did SMNG act imprudently in its gas purchasing and/or hedging practices during this ACA period?
- b. Should Staff's proposed disallowance of gas costs be adopted by the Commission in this proceeding?
- c. If so, what is the appropriate adjustment to be made to SMNG's gas costs?
