NOTICE OF CHANGE APPLICATION

COMES NOW Southwestern Bell Telephone Company, d/b/a AT&T Missouri, pursuant to §392.550 RSMo., and for its Notice of Change Application seeking to expand interconnected voice over Internet protocol service to additional areas,¹ states as follows:

1. Southwestern Bell Telephone Company, d/b/a AT&T Missouri ("AT&T Missouri") is a Delaware corporation with its principal Missouri office at One AT&T Center, Room 3520, St. Louis, Missouri 63101.
2. AT&T Missouri seeks registration to offer interconnected voice over Internet protocol service to the Herculaneum-Pevely exchange.
3. Attached is an affidavit signed by an officer of AT&T Missouri affirming this request.

I, John Sondag, a natural person, do hereby swear and affirm that I am an officer of Southwestern Bell Telephone Company, d/b/a AT&T Missouri ("AT&T Missouri"), and that the attached application and the following are true and correct to the best of my knowledge, information and belief:

- (1) A list of additional exchanges to be served by AT&T Missouri is accurately set forth in the application to which this affidavit is attached.
- (2) AT&T Missouri's principal executive officers are: David C. Nichols, President and Chief Executive Officer; Corey Anthony, Senior Vice President - Core Installation and Maintenance; Ernie Carey, Senior Vice President - Construction and Engineering; Rick Felts, Senior Vice President - Information Technology Operations; William Hogg, Senior Vice President - Network Planning and Engineering; Jerrie Kertz Senior Vice President - Network Operations Planning and Support; Gary M. Ludgood, Senior Vice President - Global Network Field Operations; Randy Tomlin Senior Vice President - U-verse Field Operations; and April J. Rodewald, Senior Vice President, General Counsel and Secretary.
- (3) AT&T Missouri is legally, financially, and technically qualified to provide interconnected voice over Internet protocol services.
- (4) AT&T Missouri is ready, willing, able, and will comply with all applicable state and federal laws and regulations imposed upon providers of interconnected voice over Internet protocol services.
- (5) AT&T Missouri will charge and collect from its end user customers on interconnected voice over Internet protocol service, and remit to the appropriate authority, fees and surcharges in the same manner as are charged and collected upon end user customers of local exchange telecommunications service and remitted by local exchange telecommunications companies, including but not necessarily limited to:

- (a) Telecommunications programs under section 209.255, RSMo;
- (b) Missouri universal service fund under section 392.248, RSMo;
- (c) Local enhanced 911; and
- (d) Any applicable license tax.

(6) AT&T Missouri will remit the annual assessment imposed by the Commission under section 386.370, RSMo.


(7) AT&T Missouri will file, either directly or indirectly through an affiliated competitive local exchange carrier, with the Commission an annual report at a time and covering the yearly period fixed by the Commission.

(8) AT&T Missouri has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. Consumer complaints may be directed to: Customer Appeals
1010 Pine St., Room 6-E-22, St. Louis MO 63101 (tn: 800-283-6407); and

(9) AT&T Missouri's interconnected voice over Internet protocol service meets the following criteria:

- (a) Enables real-time, two-way voice communications;
- (b) Requires a broadband connection from the user's location;
- (c) Requires Internet protocol-compatible customer premises equipment; and
- (d) Permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network.

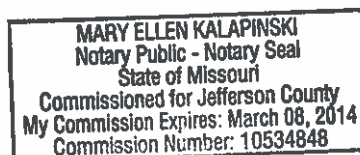


