**ORDER SETTING EVIDENTIARY HEARING DATE  
AND PROCEDURAL SCHEDULE**

On April 26, 2021, Greg Stiens filed a complaint with the Commission against The Empire District Gas Company d/b/a Liberty. On October 14, 2021, the Commission initiated an evidentiary hearing via telephone and videoconference. Prior to the presentation of evidence, Complainant made an oral motion to reset the hearing so that he could present his case in person. The Commission granted that motion.

On October 20, 2021, Staff filed, on behalf of the parties, proposed hearing dates of December 15, or 16 of 2021. Commission Rule 20 CSR 4240-2.070(15)(E) requires that the evidentiary hearing be held within thirty 30 miles of Maryville, MO.

The Commission will set a hearing date.

**THE COMMISSION ORDERS THAT:**

1. An evidentiary hearing is set for December 16, 2021, beginning at 9:30 a.m. The hearing will be held in the Maryville City Hall, City Council Chambers, at 415 N. Market St., in Maryville, Missouri, 64468. This building meets accessibility standards
