ORDER DIRECTING STATUS REPORT

On March 31, 2022,¹ the parties asked the Commission to amend the procedural schedule to allow them time to finalize a settlement agreement. The Commission amended the procedural schedule as requested, and the revised schedule directed Symmetry Energy Solutions (Symmetry) to file its direct testimony by April 29. Symmetry did not file that testimony, and on May 5, the Commission directed Symmetry to file a status report.

Symmetry filed its status report on May 10, explaining that it continues to negotiate a settlement agreement and asking the Commission to direct it to file a further status report by May 16.

The Commission is willing to allow the parties as much time as they need to negotiate a settlement. However, this complaint remains on the Commission calendar for four days of hearing beginning on July 18. If those hearing days will not be needed, the

Commission would like to clear them from its calendar. The Commission will direct Symmetry to file a further report regarding the status of this complaint. As part of that status report, Symmetry shall indicate whether the previously established procedural schedule, including the July 18-21 hearing dates, should be cancelled.²

THE COMMISSION ORDERS THAT:

1. Symmetry shall file a report regarding the status of this complaint by May 16, 2022.
2. This order shall be effective when issued.
