## FOURTH ORDER GRANTING REQUEST FOR ADDITIONAL TIME

Issue Date: January 10, 2022 Effective Date: January 10, 2022

The Commission's Staff filed a complaint on September 28, 2021, against Spire Missouri, Inc. d/b/a Spire, alleging various violations of Commission's gas safety rules. The Commission issued its order, pursuant to Commission Rule 20 CSR 4240-2.070 giving Spire 30 days, until October 28, 2021, to respond to Staff's Complaint. On October 28, 2021, Spire filed a request that it be given until December 3, 2021 to file a resolution, answer, or status update, and stating that Spire and the Staff of the Commission are engaged in ongoing discussions regarding a resolution to the complaint, which request was granted. On December 3, 2021, Spire filed a status update and second request for additional time, asking that the Commission extend the deadline for filing its response to Staff's Complaint to December 20, 2021. On December 20, 2021, Spire filed a third request for additional time to file a resolution, answer or status update, stating that Spire and Staff were engaged in ongoing discussions regarding a resolution to the Complaint, and are hopeful that a final draft of an agreement resolving the matter will be

completed in the near future, and on January 7, 2022, Spire filed a fourth request requesting time to file a resolution, answer or status update for the same reasons.

The Commission finds Spire's request reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

- 1. Spire's request for additional time is granted.
- 2. Spire shall file its answer to Staff's complaint no later than January 24, 2022.
- 3. This order is effective when issued.
