NOTICE OF DISMISSAL

COMES NOW Spire Missouri Inc. (“Spire Missouri”) and, pursuant to the Settlement Agreement attached as Appendix A, files this Notice of Dismissal, stating as follows:

1. On February 14, 2023, Mr. Bobby J. Armour filed a Formal Complaint with the Missouri Public Service Commission (“Commission”) against Spire Missouri, commencing the above-referenced case.
2. Spire Missouri and Mr. Armour entered into a Settlement Agreement with assistance from the Staff of the Commission (“Staff”) to fully resolve the Formal Complaint. The Settlement Agreement is attached as **Appendix A**.
3. The obligations under the Settlement Agreement triggering a dismissal were fulfilled by both parties as of June 26, 2023.
4. Under the Settlement Agreement, if Mr. Armour did not file a Notice of Dismissal after seven (7) days of Spire Missouri notifying him that it had fulfilled its obligations, Spire Missouri had permission to file a Notice of Dismissal with the Commission. Spire Missouri sent such notification on June 26, 2023 to both Mr. Armour and Staff.

5. As seven (7) days have passed since the notification and Mr. Armour has not filed a Notice of Dismissal, Spire Missouri hereby submits this Notice of Dismissal of Mr. Armour's Formal Complaint as agreed upon in the Settlement Agreement.

WHEREFORE, Spire Missouri respectfully requests that the Commission accept this Notice of Dismissal pursuant to the Settlement Agreement and dismiss this Complaint.
