**ORDER ESTABLISHING TIME TO RESPOND TO
STAFF’S RECOMMENDATION**

On September 30, 2016, Missouri Gas Energy (“MGE”), an operating unit of Laclede Gas Company, filed a petition with the Missouri Public Service Commission (“Commission”) to change its Infrastructure System Replacement Surcharge (“ISRS”) rate schedule to recover ISRS-eligible costs. On November 29, 2016, the Commission’s Staff recommended that MGE should be allowed to recover the amount of \$3,362,598 through its ISRS. The Commission will require MGE and any other interested party to respond to Staff’s recommendation.

THE COMMISSION ORDERS THAT:

1. Missouri Gas Energy shall respond to Staff’s recommendation no later than December 9, 2016.
2. Any other party wishing to respond or object to Staff’s recommendation shall do so no later than December 9, 2016.

3. This order shall be effective when issued.
