On August 18, 2016, Union Electric Company d/b/a Ameren Missouri filed a tariff (Tracking No. JG-2017-0033) intended to end its current infrastructure system replacement surcharge (ISRS) and reset the value to zero. The Staff of the Missouri Public Service Commission has filed a motion for the Commission to approve the tariff sheets filed by Ameren Missouri. Additionally, Staff requests the opening of this case to receive Staff's final report with regard to Ameren Missouri's ISRS over- or underrecovery for the period May 1, 2015 through September 16, 2016.
