The Commission opened this case on February 22, 2017 to facilitate Staff's investigation into Spire's compliance with the gas supply documentation requirements of its Cost Allocation Manual (CAM) and its Standards of Conduct. In a status report filed on June 6, 2018, Staff informed the Commission that it has completed its investigation and will be working with Spire to re-write its CAM and Standards of Conduct. Staff asked the Commission to open a new working case to facilitate that re-write and advised the Commission to close this investigative case once the new case was opened.

The new case to facilitate the re-write of Spire's CAM and Standards of Conduct has been opened as File No. GW-2018-0367. This case can now be closed.
