The Commission's Staff filed a motion on March 16, 2018, explaining its concern that Spire Missouri, Inc. may be improperly disconnecting customers under some circumstances. Staff asks the Commission to open a formal investigative file regarding Spire's service and billing practices for residential customers so that Staff will have the means to compel Spire to cooperate with Staff's investigation. The Commission will open this case to facilitate that investigation, and will direct Staff to report its findings.

This is only a fact-finding investigation and is not a contested case. The Commission will not take any action regarding Spire's actions within the confines of this investigation. If the investigation reveals that any such action is appropriate, Staff may file a formal complaint or other appropriate pleading within a new file to institute contested case procedures.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Staff shall undertake an investigation of Spire Missouri, Inc.'s service and billing practices for residential customers.
- 2. Staff shall file a progress report regarding its investigation no later than May 31, 2018.

3. This order shall be effective when issued.
