# STAFF RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS TO ADJUST THE WEATHER NORMALIZATION ADJUSTMENT RIDER RATES OFSPIRE EAST AND SPIRE WEST

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and respectfully states as follows:

- 1. On September 1, 2020, Spire Missouri, Inc. (Spire) filed two tariff sheets to revise its weather normalization adjustment rider (WNAR) rates for Spire East and Spire West to go into effect October 1, 2020. On September 2<sup>nd</sup>, the Commission issued its *Order Directing Staff Recommendation and Setting Time for Responses* (Order) ordering Staff to file its Recommendation no later than September 11, 2020. These tariff sheets have issue dates of August 31, 2020 and effective dates of October 1, 2020.
- 2. Spire filed two substitute tariff sheets on September 11, 2020, to incorporate the true-up of the reconciliation due to expire on September 30, 2020.
- 3. Accompanying this pleading, and incorporated herein by reference, is Staff's Memorandum recommending Commission approval of the WNAR rates Spire filed in its tariff sheets.
- 4. The effect of Spire's WNAR tariff sheet filings means that residential customers of both Spire East and Spire West who used 100 Ccf in a given billing month would see a \$1.12 bill increase from currently effective rates. Staff notes that Spire experienced warmer than normal weather in both rate districts, thus causing the

WNAR rates to be positive toward the company when compared to the WNAR rates approved in Spire's previous WNAR filing.

WHEREFORE, as set forth in Staff's Recommendation memorandum, Staff recommends the Commission issue an order approving the Spire East's WNAR tariff sheet as filed and Spire West's WNAR tariff sheet, as substituted September 11, 2020:

On August 31, 2020, Spire filed one tariff sheet to adjust its weather normalization adjustment rider (WNAR) rates in JG-2021-0051 and JG-2021-0052. On September 1, 2020, Spire opened GO-2021-0057 and requested approval of the tariff sheets filed in JG-2021-0051 and JG-2021-0052. On September 2, 2020, the Commission directed Staff to file a recommendation on the pending tariff sheets no later than September 11, 2020. On September 11, 2020, Spire filed two substitute tariff sheets in JG-2021-0052 to incorporate the true-up of the reconciliation due to expire on September 30, 2020.

Spire's WNAR became effective on April 19, 2018. The purpose of the tariff is to adjust revenues for differences between actual heating degree days (AHDD) and normal heating degree days (NHDD). This is Spire's fifth WNAR filing. Spire's current and proposed rates are included in Table 1 below.

Table 1: Current and Proposed WNAR Rates by District and Class.

District	Current	Proposed
Spire East	(\$0.00955)	\$0.00160
Spire West	(\$0.00753)	\$0.00369

Spire experienced warmer than normal weather in both of its rate districts, causing the WNAR rate to be positive compared to the WNAR rate approved in Spire's last rate filing. This means a residential customer in the Spire East and Spire West rate districts that used 100 ccf/therms in a given billing month would see a line item increase of approximately \$1.12 in their bill from the currently effective WNAR rate.
