ORDER SCHEDULING A PROCEDURAL CONFERENCE

On May 24, 2022, Spire Missouri, Inc. (Spire) submitted a draft Cost Allocation Manual (CAM) along with a motion asking the Commission to approve that CAM. Spire's motion accompanying the CAM represents that the draft CAM contains language acceptable to the Commission's Staff, but acknowledges that Public Counsel has not accepted the CAM as written. Indeed, in a response filed on June 21, 2022, Public Counsel explained the areas in which it disagrees with the language contained in the draft CAM and suggests that some of its concerns might be resolved through further discussions. In addition, the Midwest Energy Consumers Group (MECG) has been allowed to intervene in this matter, but has not yet taken a position on the draft CAM.

The Commission would like to proceed expeditiously to consider Spire's CAM. To that end, the Commission will schedule a procedural conference at which the parties can discuss the appropriate means by which this matter can be resolved.

1. A procedural conference is scheduled for July 26, 2022, at 2:00 p.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City,
