## ORDER DIRECTING A STAFF RECOMMENDATION AND SETTING A TIME FOR RESPONSES

Issue Date: July 5, 2022

Effective Date: July 5, 2022

On July 1, 2022, Spire Missouri Inc. d/b/a Spire Missouri East and Spire Missouri West (Spire) filed an application to update its Weather Normalization Adjustment Rider (WNAR) and accompanying tariff sheets (Tracking No. JG-2023-0002). Spire projects the changes to the WNAR tariff sheets will increase the monthly bill for the average Spire East residential customer by approximately \$1.32 per month, and the monthly bill for the average Spire West residential customer by approximately \$0.90 per month.

The tariff sheets bear a September 1, 2022, effective date. The Commission will direct the Staff of the Commission to file a recommendation, and will establish a deadline for any other entity to file a response to the proposed tariff changes.

### THE COMMISSION ORDERS THAT:

1. No later than July 20, 2022, the Staff of the Commission shall file a recommendation regarding Spire's WNAR tariff sheets.
2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so no later than July 27, 2022.

3. This order is effective when issued.
