ORDER GRANTING APPLICATION TO INTERVENE

On December 27, 2022, Spire Missouri Inc., filed an application and petition with the Commission pursuant to Sections 393.1009, 393.1012, and 393.1015, RSMo, and Commission Rules 20 CSR 4240-2.060, 2.080, and 3.265, requesting that the Commission authorize changes to the Spire Missouri East and Spire Missouri West Infrastructure System Replacement Surcharges (ISRS). Spire Missouri also included a tariff sheet, Tracking No. JG-2023-0115, setting out the rates it intends to become effective.

The Commission directed notice and set a deadline of January 26, 2023, for applications to intervene. On January 26, 2023, the Missouri Energy Consumers Group (MECG) filed a timely application to intervene. More than ten days have passed since the application was filed and no one has responded.

After considering the unopposed application to intervene, the Commission finds that MECG has interests which are different from that of the general public and allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene of MCEG is granted.
2. This order is effective when issued.
