## ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On December 22, 2021, Spire Missouri Inc. d/b/a Spire submitted an application requesting financing authorization in the amount of \$800 million through December 2024, subject to all of the terms and conditions approved by the Commission in File No. GF-2020-0334.

Spire also requests waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017. Spire further requests expedited treatment such that the Commission issues a final order in this matter no later than March 1, 2022.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding Spire's application.

### THE COMMISSION ORDERS THAT:

- 1. No later than January 24, 2022, Staff shall file a recommendation regarding Spire's application requesting financing authorization in the amount of \$800 million, or a request for an extension of time.
  - 2. This order shall be effective when issued.
