1 Q. Please state your name and business address.

2 A. My name is Gary M. Denny and my business address is 10700 East 350 Highway,
3 Kansas City, Missouri, 64138.

4 Q. By whom are you employed and in what capacity?

5 A. I am employed by Aquila, Inc. ("Aquila" or "Company") as a Senior Regulatory Analyst
6 in the Regulatory Services Department.

7 Q. What are your duties and responsibilities at Aquila?

8 A. I am responsible for tariff filings, changes to rules and regulations, affiliate filings and
9 various other analyses as needed.

10 Q. Please state your educational background and experience.

11 A. I have an M.B.A. from Rockhurst University and a B.S. in Business Administration
12 with a major in Accounting from Central Missouri State University. I have held various
13 positions in Aquila including positions in Accounting, Customer Service, Marketing
14 and Financial Management. In 2002, I accepted a position in the analytical section of
15 Aquila's Regulatory Services.

16 Q. What is the purpose of your testimony in this case before the Missouri Public Service
17 Commission ("Commission")?

18 A. I am sponsoring the Minimum Filing Requirements ("MFR") of 4 CSR 240-3.030.

1 Q. Have the MFR for a general rate increase under 4 CSR 240-3.030 been included as a
2 part of the Company's filing?

3 A. Yes.

4 Q. Are revised tariffs also filed?

5 A. Yes. Revised steam P.S.C. MO. No. 1 tariffs have been filed.

6 Q. How do the tariff sheets implement the proposed increase in revenue?

7 A. All tariff charges were multiplied by the ratio of the total proposed increase minus the
8 proposed increase to other revenues, divided by the total annualized revenue minus
9 annualized other revenues. The equation is $(\$5,029,944 - \$0) / (\$11,356,018 - \$601)$.

10 This is an increase of 44.3%.

11 Q. Does this conclude your testimony?

12 A. Yes it does.
