### STAFF'S RECOMMENDATION

Comes now the Staff of the Missouri Public Service Commission ("Staff") and for its recommendation states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On September 9, 2008, a Unanimous Stipulation and Agreement was filed in this matter, on behalf of Staff; Trigen-Kansas City Energy Corporation ("Trigen"), Kansas City Power & Light Company; the City of Kansas City, Missouri; Jackson County, Missouri; and the Office of Public Counsel.
- 2. On September 18, 2008, the Commission issued its Order Approving Unanimous Stipulation and Agreement and Authorizing Tariff Filing ("Order") after hearing. Within this Order Trigen was "authorized to file tariffs in compliance with the terms of the Stipulation and Agreement."
  - 3. On September 26, 2008, Trigen filed Compliance tariff sheets.
- 4. On September 29, 2008, the Commission issued its Order Directing Staff to File Recommendation regarding Trigen's tariff compliance filing.
- 5. On October 10, 2008, Trigen filed a substitute tariff sheet to correct an error discovered pursuant to Staff's review.
- 6. In the attached memorandum, labeled Attachment A, the Staff notes that it has reviewed the tariff sheets as filed by Trigen on September 26, 2008, and substituted October 10,

2008, and states Trigen's filing, as substituted, complies with the Commission's Order. Staff recommends approval of these tariff sheets, as listed in Staff's memorandum.

Wherefore, the Staff respectfully recommends the Commission approve Trigen's tariff filing, as substituted.

On September 26, 2008, Trigen-Kansas City Energy Corporation (Trigen) filed with the Commission thirty-seven (37) tariff sheets (18 rates and 19 rules tariff sheets) with an issue date of September 26, 2008, and a proposed effective date of November 1, 2008. These tariff sheets are designed to comply with Ordered Paragraphs 5 and 6 of the Commission's September 18, 2008 Order Approving Unanimous Stipulation and Agreement and Authorizing Tariff Filing (Order) which Ordered Paragraphs state:

- 5. Trigen-Kansas Energy Corporation is authorized to file tariffs in compliance with the terms of the Stipulation and Agreement.
- 6. Tariffs filed in accordance with Ordered Paragraph #5 shall be filed with an effective date which is at least 30 days after its issue date; however, Trigen-Kansas City Energy Corporation may seek expedited approval of its tariffs, if such tariffs are in compliance with the Stipulation and Agreement, as described in the body of this order.

In the summary on page 5 of the Order, the Commission states:

The Agreement provides that Trigen should be authorized to file revised tariff sheets containing new rate schedules for steam heat service designed to produce an increase in Trigen's overall Missouri jurisdictional gross annual steam heat service revenues, exclusive of any applicable license, occupation, franchise, gross receipts taxes or other similar fees or taxes, in the amount of \$1,228,000 annually. This represents an approximate increase of 20.5% in Trigen's gross annual steam tariff revenues and is 100% of the amount requested by the company.

On October 10, 2008, Trigen, at the request of the Missouri Public Service Commission Energy Department Staff (Staff), filed one (1) substitute tariff sheet.

The Staff has reviewed the filed tariff sheets, as substituted, and is of the opinion that, based on an authorized increase in revenues of \$1,228,000, they are in compliance with the Commission's Order. Staff therefore recommends that the Commission approve the following proposed tariff sheets, as filed on September 26, 2008, and substituted on October 10, 2008, to become effective on November 1, 2008 as requested by Trigen, or permit the tariff sheets to go into effect by operation-of-law:
