- 1. In the attached Memorandum (Appendix A) the Staff recommends the Missouri Public Service Commission (Commission) approve the tariff sheet Aquila filed on July 11, 2008, to become effective September 1, 2008. Aquila filed the tariff sheet to make a quarterly cost adjustment required as part of the Stipulation and Agreement approved by the Commission in Case No. HR-2005-0450. That Stipulation and Agreement includes a "fuel rider" that requires quarterly rate adjustments, with not more frequent than annual true-ups.
- 2. Staff has reviewed the tariff sheet and is of the opinion that the quarterly cost adjustment for the 2008 Q2 has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider tariff sheet and complies with the Commission's Order in HR-2005-0450.
- 3. The Staff recommends the Commission issue an order approving the proposed tariff sheet to be effective September 1, 2008, or allow the sheet to go into effect by operation of law.

WHEREFORE, the Staff of the Missouri Public Service Commission recommends the Commission either approve to become effective September 1, 2008 or allow to go into effect by

operation of law on September 1, 2008, the Tariff Sheet Aquila, Inc. d/b/a Aquila Networks–L&P filed on July 11, 2008, to wit:

On July 11, 2008, Aquila, Inc. d/b/a Aquila Networks – L&P (Aquila or Company) of Kansas City, Missouri, filed with the Commission one (1) tariff sheet with an issue date of July 11, 2008, and a proposed effective date of September 1, 2008, to add the quarterly cost adjustment for the second quarter of 2008 as required by Company's Quarterly Cost Adjustment Rider, which the Commission approved in Case No. HR-2005-0450.

The Commission assigned Case No. HR-2007-0028 for the filings during the initial audit period (Q206 – Q406) and any subsequent prudence review and true-up of the revenues collected during that audit period.
