## ORDER APPROVING TARIFF SHEET FILED IN COMPLIANCE WITH COMMISSION'S ORDER

On April 15,<sup>1</sup> KCP&L Greater Missouri Operations Company ("GMO")<sup>2</sup> submitted a proposed tariff sheet that contains a quarterly cost adjustment to allow customer rates to change with fuel cost changes. The tariff sheet was filed pursuant to the terms of the Stipulation and Agreement approved by the Commission in File No. HR-2005-0450. On May 7, GMO filed substitute tariff sheet to correct two dates. GMO's tariff sheet, Tariff No. YH-2009-0734, has a proposed effective date of June 1, 2009.

On May 11, 2009, the Staff of the Missouri Public Service Commission filed a recommendation. Staff states that it has reviewed Tariff No. YH-2009-0734 and is of the opinion that it has been calculated in accordance with the provisions of the Quarterly Cost Adjustment Rider and complies with the Commission's order in File No. HR-2005-0450. Staff recommends that the Commission approve the proposed tariff

sheet to become effective on June 1, 2009. No objections to the tariff were filed and no proper entity filed a response to Staff's recommendation.

The Commission has reviewed GMO's tariff sheet, Staff's verified recommendation, and the other pleadings. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Commission's previous order and shall be approved subject to refund pursuant to the terms of the Stipulation and Agreement approved in File No. HR-2005-0450, as ordered below.

### THE COMMISSION ORDERS THAT:

1. Tariff No. YH-2009-0734, submitted on April 15, 2009, is approved, subject to refund pursuant to the terms of the Stipulation and Agreement approved in File No. HR-2005-0450 for steam service rendered on or after June 1, 2009. The tariff sheet approved is:
