STAFF'S STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and in response to the Commission's February 9, 2011, *Order Opening File and Directing Filing* by the Staff of its initial report not later than June 9, 2011, and Staff's June 6, 2011 Initial Report which required an interim status report no later than August 9, 2011, and Staff's August 9, 2011 filing of an Interim Status Report which indicated Staff would file a Final Report or Status Report no later than October 31, 2011, files this Status Report.

As noted in its Initial Report, the Staff has been actively investigating this incident, which occurred at about 1:52 PM on February 2, 2011 at the intersection of 107th Street and Blue Ridge Boulevard in Kansas City, Missouri. The incident was the result of a release of natural gas from a fractured 16-inch diameter steel natural gas transmission pipeline owned and operated by Missouri Gas Energy (MGE), a division of Southern Union Company. There was no ignition of the natural gas, no injuries and no known damage to property other than property owned by MGE. Since the repair, MGE has been operating at a reduced pressure (approximately 160-170 psig, which is less than 80% of the operating pressure at the time of the incident).

Status of the Investigation

The Staff has received and reviewed information provided by MGE in response to its information requests. Staff has evaluated alternatives for replacement and testing of MGE pipelines and has reached decisions regarding how to proceed. The Staff is in the final stage of compiling information for its final report. The Final Report concerning this incident will be filed no later than December 9, 2011.

WHEREFORE, Staff requests that the Commission accept this Interim Status Report concerning its investigation of the natural gas release in Kansas City, Missouri, with the understanding that Staff will file a Final Report or a Status Report no later than December 9, 2011.
