Based on the investigation by the Commission's staff ("Staff") into the incident described in the title of this file, Staff filed a report. Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed a response. Staff filed a reply.

Staff's report includes recommendations related to fire extinguishers, service line information, and compression coupling failures. ⁴ Of those recommendations, Ameren Missouri objects to none, ⁵ but states that compliance with the recommendation related to service line information will require a year to complete. ⁶ Staff's reply includes a motion for an order requiring Ameren Missouri to implement all recommendations and to advise the Commission's Safety Engineering Unit Staff regularly of Ameren Missouri's progress in doing so. ⁷
