ORDER OPENING FILE AND DIRECTING FILING

The Commission's Staff filed a motion on July 19, 2018, asking the Commission to open a file for investigation of a natural gas safety incident in Kansas City, Missouri. Staff's motion explains the incident occurred on July 16, 2018, in an area served by Spire Missouri West. Staff's initial investigation indicates that a contractor crew was working for Spire Missouri West at 1106 Paseo Boulevard when natural gas was released from a pipeline at 10:20 a.m. Two workers sustained injuries from a natural gas flash fire. Staff asks the Commission to open a file to receive a report resulting from the investigation of the incident by the Commission's Safety Engineering Department.

The Commission will grant Staff's Motion.

THE COMMISSION ORDERS THAT:

1. Reports regarding the incident described in the body of this order shall be filed under this file number.
2. Staff shall file a report regarding the incident described in the body of this order, or a report on the status of its investigation, not later than January 21, 2019.

3. This order shall be effective when issued.
