On September 1, 2021, the Commission directed its Staff to investigate Spire Missouri, Inc. d/b/a Spire's compliance with the Commission's gas safety rules related to the mechanical joining qualifications of its employees. The Commission ordered its Staff to file progress reports regarding its investigation.

In its fifth progress report on July 11, 2023, Staff explains that its investigation is proceeding and asks that it be directed to file either a report regarding its investigation, or a further progress report by no later than October 27, 2023. The Commission will order Staff to file a further report.
