ORDER ADOPTING PROCEDURAL SCHEDULE AND FURTHER SUSPENDING TARIFF

Issue Date: August 28, 2008 Effective Date: August 28, 2008

On August 5, 2008, acting on motions filed by the Commission's Staff and the Office of the Public Counsel, the Commission suspended a tariff filed by Laclede Gas Company until December 6, 2008. The Commission convened a prehearing conference on August 21, and directed the parties to file a proposed procedural schedule by August 26. On August 26, the parties jointly filed a proposed procedural schedule leading to an evidentiary hearing on December 8 and 9. Since all parties accept the proposed schedule, the Commission will adopt it.

The Commission notes that hearing room 310 has previously been reserved for a hearing in another case. Therefore, this hearing will be scheduled in hearing room 305.

The Commission initially suspended Laclede's tariff for only 120 days, until December 6. Since the parties propose a hearing beginning after that date, the Commission concludes the tariff should be suspended the additional six months allowed by Section 393.150.2, RSMo (2000).

The parties shall comply with the following procedural requirements:

(A) Testimony shall be prefiled as defined in Commission Rule 4 CSR 240-2.130.

All parties must comply with this rule, including the requirement that testimony be filed on

line-numbered pages.

(B) The parties shall agree upon and Staff shall file a list of the issues to be heard,

the witnesses to appear on each day of the hearing, the order in which they will be called,

and the order of cross-examination for each witness. The list of issues should be detailed

enough to inform the Commission of each issue that must be resolved. The Commission

will view any issue not contained in this list of issues as uncontested and not requiring

resolution by the Commission.

(C) Each party shall file a simple and concise statement summarizing its position

on each disputed issue.

(D) All pleadings, briefs, and amendments shall be filed in accordance with

Commission Rule 4 CSR 240-2.080. Briefs shall follow the same list of issues as filed in

the case and must set forth and cite the proper portions of the record concerning the

remaining unresolved issues that are to be decided by the Commission.

(E) All parties shall bring an adequate number of copies of exhibits that they intend

to offer into evidence at the hearing. If an exhibit has not been prefiled, the party offering it

must bring, in addition to the copy for the court reporter, copies for the five Commissioners,

the Presiding Judge, and all counsel.

All parties shall provide objections and answers to data requests on the following schedule: after the filing of direct testimony, objections shall be made within five business days of receipt, and answers shall be due within ten business days of receipt; after the filing of surrebuttal testimony, objections shall be made within two business days of receipt, and answers shall be due within five business days of receipt.
- 4. The hearing will be held at the Commission's office at the Governor Office Building, Room 305, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act.
