ORDER SUSPENDING TARIFF, DIRECTING NOTICE,
AND SETTING INTERVENTION DATE

Issue Date: August 7, 2008

Effective Date: August 17, 2008

On August 4, 2008, Union Electric Company, d/b/a AmerenUE (“AmerenUE”), filed a petition with the Missouri Public Service Commission to change its Infrastructure System Replacement Surcharge (“ISRS”) rate schedule to reflect ISRS-eligible infrastructure system replacements made during the period from November 1, 2007, through May 31, 2008. Section 393.1015.2(3), RSMo Supp. 2007, requires the Commission to act on AmerenUE’s application no later than 120 days after it was filed. Consequently, the Commission must issue a decision regarding AmerenUE’s petition effective no later than December 2, 2008.

With its application, AmerenUE filed a tariff that would implement the surcharge effective September 3, 2008. The Commission will suspend that tariff until December 2, 2008, to allow sufficient time to review AmerenUE’s ISRS application.

Section 393.1015.1(2) requires the Commission to publish notice of AmerenUE’s filing. Therefore, the Commission will give notice of this application to the public and to others who may be interested. The Commission will also set a date for the filing of intervention requests.

IT IS ORDERED THAT:

1. The tariff sheet filed by Union Electric Company, d/b/a AmerenUE, on August 4, 2008, and assigned Tariff File No. JG-2009-0093, is suspended until December 2, 2008, unless otherwise ordered by the Commission. The tariff sheet suspended is:

2. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in the service area of Union Electric Company, d/b/a AmerenUE, as well as to the corresponding governing body for the City of St. Louis. In addition, the Data Center shall mail a copy of this notice to each party in GR-2007-0003, AmerenUE's last general rate case.

3. The Information Officer of the Missouri Public Service Commission shall make notice of this order available to the media serving AmerenUE's service area and to the members of the General Assembly representing AmerenUE's service area.

4. Any person wishing to intervene in this matter shall file an application to do so no later than August 27, 2008. Such application shall be filed with:
