ORDER GRANTING JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

On March 23, 2010,¹ the Commission issued a Notice of New Proceeding. The Commission did so in response to a March 15 revised transportation tariff filing by Missouri Gas Energy, a division of Southern Union Company (hereafter "MGE"), and a Motion to Create New Docket and Set Prehearing Conference filed by Constellation NewEnergy-Gas Division, LLC (hereafter "Constellation").

The Commission ordered the parties to file a proposed procedural schedule no later than April 30. Staff filed such a schedule on May 3, along with a Joint Motion to Late File Proposed Procedural Schedule, which the Commission granted. The Commission found the parties' proposed procedural schedule unsuitable, and issued an order setting a different schedule on May 5.

On May 6, the parties filed a Joint Motion to Amend Procedural Schedule. The parties explain that the Commission's May 5 schedule is unworkable for them, as they have witnesses and counsel unavailable on the hearing dates reserved by the Commission. The parties propose an alternative schedule, and state that MGE agrees to extend its tariff effective date to September 15 to allow the Commission the needed time to rule upon the case.

The Commission has Joint Motion to Amend Procedural Schedule, finds it reasonable, and will grant it.

1. The Joint Motion to Amend Procedural Schedule is granted.
