**JOINT MOTION TO POSTPONE FILING OF LIST OF ISSUES,
WITNESSES AND POSITIONS UNTIL DECEMBER 28, 2010**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and on behalf of itself, Union Electric Company d/b/a Ameren Missouri, the Office of the Public Counsel, and the Missouri Department of Natural Resources (collectively referred to hereinafter as "the Parties"), requests that the Missouri Public Service Commission ("the Commission") postpone the filing of the list of issues, witnesses and position statements in this matter until December 28, 2010. In support of this motion, Staff states as follows:

1. The Parties have reached an agreement in principle as to a unanimous global settlement of Case No. GR-2010-0363. The Parties hope to have this agreement memorialized in a formal stipulation filed with the Commission on or before Tuesday, December 28, 2010. Such an agreement will render moot the issues raised in this case.

2. A list of the issues to be heard, the witnesses to appear at the hearing, the order in which they will be called, and the order of party cross-examination for each witness, and each party's position statement are due to be filed today, December 23, 2010. Postponing this filing until December 28, 2010, will permit the Parties to concentrate fully on memorializing and filing a formal stipulation in GR-2010-0363.

3. Should the parties file a unanimous global stipulation on or before Tuesday, December 28, 2010, in Case No. GR-2010-0363, the Parties ask that the Commission suspend

the procedural schedule previously ordered in this matter, including the filing that is the subject of this motion.

WHEREFORE, Staff, on behalf of the Parties, requests that filing of the list of issues, witnesses, order of cross-examination and party position statements be postponed until December 28, 2010, and for other such relief as requested above.
